This is to advise you of the intent of the San Diego Performance Cluster to utilize the provisions of Article 12.5.C.5 of the National Agreement to involuntarily reassign from the craft and/or installation up to 190 full-time carriers from 23 separate post offices. The impacts are based on projected MIARAP route reductions. The number of carriers to be reassigned from each office is set forth below.



The impacted carriers will be notified of their involuntary reassignments by separate letter. Although the final placement date would normally occur no earlier than March 3, 2009, it may be necessary to begin the reassignment process earlier than that date due to the ongoing loss of volume and the financials of the company. It may also be necessary to utilize the provisions of Article 7.2.B of the National Agreement to detail some or all of the impacted carriers during the notice period. If this becomes necessary, we will advise you.

Reductions to the impacts identified above will be made for attrition prior to initiating any reassignments.

By copy of this notice, the Pacific Area will withhold up to 190 full-time residual vacancies in the carrier, clerk, mail handler and custodial crafts for placement of the impacted carriers in offices within a 500 mile radius of the impacted sites.

Copies of the automated impact statements and the MIARAP worksheet are enclosed along with seniority lists identifying the junior impacted full-time carriers in each of the offices.
