Burrus Elected President

APWU Executive Vice President William Burrus has been elected to serve as APWU President in the 2001 APWU National Officers' Election. With 44,133 votes cast in his favor, Burrus defeated Central Regional Coordinator Leo Persails (27,885 votes) and North Jersey Area Local Secretary-Treasurer John McGovern (12,295 votes).
