Ballot Placement Set, Candidates Certified, For Election of APWU National Officers

Ballots are scheduled to be mailed to APWU members on or after Wednesday, Sept. 12, 2007, but no later than Saturday, Sept. 15, 2007. Members in good standing who have not received a ballot by Thursday, Sept. 20, should notify their local or contact the American Arbitration Association between the hours of 9 a.m. and 5 p.m., Monday-Friday, Eastern Time, at 800-529-5218 to request a duplicate. You will be

asked to provide your name, the last four digits of your Social Security number, along with your local, craft, mailing address, and telephone number, in order to receive a duplicate ballot. You also may request a ballot via e-mail to apwu@adr.org.

To be valid, ballots must be in the designated post office box by Friday, Oct. 5, at 2 p.m.
