# Ballot Placement Set, Candidates Certified, For Election of APWU National Officers

Secretary-Treasurer Liz Powell has certified the following union members as candidates to national office by referendum balloting, as mandated by the APWU Constitution and Bylaws.

A drawing to determine the order candidates' names will appear on the ballot was held on Tuesday, June 22,

2010, at 10 a.m. Incumbent officers are listed first, and are denoted by (I) appearing after their name.

## **Mailing of the Ballots**

Ballots are scheduled to be mailed to APWU members on or after Monday, Sept. 13, 2010, but no later than Wednesday, Sept. 15, 2010. Members in good standing who have not received a ballot by Monday, Sept. 20, should notify their local or contact the American Arbitration Association between the hours of 9 a.m. and 5 p.m., Monday-Friday, Eastern Time, at 800-529-5218 to request a duplicate. You will be asked to provide your name, the last four digits of your Social Security number, along with your local, craft, mailing address, and telephone number, in order to receive a duplicate ballot. You also may request a ballot via e-mail to [apwu@adr.org](mailto:apwu@adr.org).

To be valid, ballots must be in the designated post office box by Tuesday, Oct. 5, at 2 p.m.
