Synopsis of Action on APWU Agenda Items

**Omar M. Gonzalez, Coordinator**

The following items/issues were discussed and disposition rendered as follows.

1. The Region has not received a recent updated Cumulative Withheld Listing. When can the Region expect an updated accurate CWL?

Management Response: *The updated list if forthcoming. It will be sent today or no later than Monday.*

2. What is the timeline for the Sacramento, Sierra Coastal and Bay Valley Impacts on the USPS Agenda?

Management Response: *Anticipated time lines are for the June Area Move Date. If different will advise.*  
[Shumate advised BV will not move Maint employees until June. LA will reassign March 10, BV Clerks March 10 ]

- 2a. When will employees be issued notice? When will preferencing begin?

Management Response: *Shumate responded letters would be issued within 2 weeks , preferencing 10 days afterward. Preferencing will be for all available assignments within the local commuting area)*

3. Mgt of the Sierra Coastal District is requiring clerks to complete PS Form 2480. What is the purpose of this requirement? What will the Form be used for? Does this indicate management's intent to reassign impacted clerks to carrier positions?

Management Response: *There should be no reason for all employees to be issued the form. Only impacted employees should get this form once identified. Shumate to check with District and update the response.*

4. The Region requests that for the Maintenance Craft for excessing of MM-7s and BEMs a demonstration with documentation that management is assigning the work to Field maint employees.

Management Response: *Area will provide all necessary documents for such impacts.*

5. Who is the designated USPS Representative at the District and Area Level for ADRP Article 12 Disputes?

Management Response: *Jay Roberts will be the lead. However, Area Specialists will do their territories. Roberts will supply the region with the names of such designees within two weeks.*

6. The 11/7/11 MOU on Reversion of Withheld/Residual Vacancies requires that prior to management taking any action to revert withheld residual vacancies the Area Labor Relations Manager will contact the Regional Coordinator for discussions related to those duty assignments. On information and belief Sierra Coastal has reverted such assignments. The Area did not comply with the MOU. The Region requests a listing of all such recently (since impact notice and last withheld list was issued) reverted assignments be issued to the Region. Also what protocol will the Area implement to abide by this MOU

Management Disposition: *Area just received MOU from HQ. Roberts will digest and get back to Region next week. It was officially issued by USPS HQ on 1/27/11. [ Region specifically identified the Lancaster assignments ]*

7. Area is to send CWHR to the Region under the provisions of the 2010-2015 CBA without the need for the Region to send requests. The Region requests CWHR for all excessing that has occurred since May 2011.

Management's Disposition: *Area concedes owes Region the reports. Webccm changed the process to be done by the Area. Shumate will follow up and send to the Region by the end of next week.*

8. The Regional requests a listing of the PSEs within the Area and their deployment/assignments.

Management's Disposition: *Shumate will follow up and send list of PSEs to the Region in impact districts.*

- 8a. Do any of the offices on the Area's Agenda list have PSEs working? Are any PSEs working with the 50 mile radius? If so will the PSE hours be made available?

Management Disposition: *This info is part of a check list developed by HQ for Area/Districts. Undetermined at this time. Will get back to the Region as soon as a determination is made on the checklist.*

9. Will VERAs be sought for these impacts? Management Disposition: *Nothing dispositive. Shumate to check*  
10. Has there been attrition since the Region was first notified? If so where and what attrition?

Management Disposition: *Shumate to issue updated Attrition list within 2 weeks and update net impacts*

11. When will the eReassign Transfer Opportunities be proffered to impacted employees and how?

Management Disposition: *Impacted office triggers this opportunity every first 21 days of each month.*

12. Does the Pacific Area have any instructions on how impacted employees can navigate the eReassign System? If so the Region requests a copy.

Management Disposition: *Shumate to secure instructions and forward to the Region next week.*

13. On the Maintenance impact offices have the MS 47 provisions been complied with? The Region requests the pertinent documents to support current compliance.

Management Disposition: *see item No. 4. Management will provide.*

14. Has the District created any new or more efficient assignments within the impacted offices, or looked for scheduling opportunities? If so who did, when, where and what are those assignments?

Management Disposition: *This too is on the checklist developed by HQ. Shumate will check. The list can be shared and will be forwarded next week.*

15. Will Area/District implement the detailing of employees in these offices? If so when, to where and for what period of time?

Management Disposition: *Yes, some impacted offices are already doing so. (e.g. Salinas is transporting employees to San Jose ) 15a. Is there any standby time at these offices? Mgt does not want to use Standby*

16. Are any of the impacted employees on light or limited duty? Management Response: *If there are they will be reassigned and accommodated.*

17. The Area requests the seniority lists for each impacted office.

Management Response: *Depending on the size of the impact it will be provided otherwise the impacted employee's listing with seniority date and other data will be provided.*

OTHER ITEMS DISCUSSED:

Management Agenda:

- Sacramento Impacts: *Nov 15 2010 Notice of 12 impacts. Take off Gridley it is no longer impacted. Move date June 2012.*
- Sierra Coastal Impacts: *Move date is June 2012. Shumate will check if 2480s were issued to these employees. USPS waived most criteria. Shumate will send. [ Letter to Guffey received ]. In Mojave 3 FT clerks will be offered carrier assignments.*
- Bay Valley Impacts: *This is the Salinas AMP impact. Available assignments are outside the 50 mile radius. Only 1 carrier assignment is available and will be offered to MPEs but Shumate not sure. Assignments (3) will be offered to clerks. San Lorenzo Impact- 2FT clerks will be offered clerical withholds in San Leandro. Santa Clara Impact- 1 FT clerk will be offered clerical withholds in San Leandro as well.*
- Other open impacts: *Are not ready to be discussed. Some may be wiped out Shumate to update impacts. February 13 meeting set. Jay Roberts will develop and send the Agenda to Region along with all the documents.*
- March Meeting: *Region will give Area possible date upon receipt of Agenda impacts.*
- Marysville Retreat/Post Excessing Report- *Brandi is out and will be back Monday. Shumate will get back to Region when contact with Brandi is made. Shumate will send the Post Excessing Report.*

Jay, as discussed this is our synopsis of what transpired at the meeting. I am sending it to you for review and if necessary clarification of our mutual understanding of the issues discussed. Also, please have Ms Shumate provide those documents promised but not yet received.

As a matter of general interest, the Postal Service is immediately waiving the following driver testing for externally hired bargaining unit employees:

- Initial Road Test (Exam 804)
- End-of-Classroom Test (Exam 805)
- End-of-Training Test (Exam 806)

Externally hired employees who were previously required to successfully complete the above-referenced testing must complete the following licensing and training courses:

- State Driving Record and Valid License Check
- USPS Defensive Driver Course, Web Based Training (WBT), #4360106
- Vehicle Familiarization, Skills Course, Controlled Drive

Upon successful completion of these courses, employees will receive certification by the Driving Safety Instructor.

The subject waiver is in effect until further notice. A waiver of the subject testing for current bargaining unit employees was put into effect on October 7, 2011.
